CUSTOMER DECLARATION

I/We accept the dispensers provided on free loan by Cornwall Supplies Company and agree to purchase from Cornwall Supplies Company, the consumable products appropriate to the type of dispensers loaned - for a minimum period of 3 years from the date of this agreement, subject to the following conditions:

1. Dispensers will be replaced free of charge if due to failure or fair wear and tear. Where applicable, failures caused by chemical attack other than from Cornwall Supplies Company's chemicals or failures from physical abuse are excluded from this warranty. All claims for repair or replacement will be at the sole discretion of Cornwall Supplies Company. This warranty in no way affects your statutory rights.
2. It is understood that if I/We cease to purchase Cornwall Supplies Company's products developed for use with the Dispenser Unit before expiration of this Agreement or I/We use other manufacturers' products in the Dispenser Unit, I/We understand and agree that I/We will be invoiced in full at that date's recommended retail price (RRP) either for each Unit and/or charged for the loan of such Units for the time when no products were being purchased from Cornwall Supplies Company and/or charged for the removal cost of each Unit and such decision will be at the sole discretion of Cornwall Supplies Company.
3. Following completion of the initial term of this Agreement I/We understand that it is automatically renewed thereafter for 12 monthly periods unless one month's written notice of termination is given by one party to the other. Failing renewal I/We agree that we will return all Dispensing Units (including keys) to Cornwall Supplies Company. I/We understand that Units returned without keys will be invoiced in full at that date's recommended retail price (RRP).
4. I/We acknowledge that any Cornwall Supplies Company's Dispenser Units (including keys) supplied under this Agreement remains the property of Cornwall Supplies Company during and after expiry of this Agreement.
5. Cornwall Supplies Company reserves the right to remove any Dispenser Unit, if in Cornwall Supplies Company's opinion, the volume of consumable product used no longer justifies the loan of the particular Dispenser Unit.
6. I / We acknowledge that fitting charges are not included under the terms of this Agreement.
